Summary of issues and actions raised		
Issue or concern raised	Action	
	Action to date: The fly-tipping has been cleared in the areas that are not private land but we need to prevent it from happening with such frequency.	
You told us that there was a problem with fly -tipping on the service road between Cavell Road and Coke Road.	<b>Future Action:</b> There are many options to explore to try to reduce this problem. The Neighbourhood Team are approaching local schools to ask for their help with designing signage to put up around the area. We are also approaching local residents to see if they may be interested in forming a community group to keep an eye on the problem and also get involved in other activities that could improve the area. <b>You were concerned</b> about drugs related activity in and around Cavell Road and Springbank area.	<ul> <li>Information: The police are aware due to calls made that residents have concerns that drug dealing may be occurring within the area. This is one of the Safer Neighbourhood Teams priority focus to address. They have run a number of plain clothes operations within the area to combat this, continue to conduct regular uniformed patrols as well as build intelligence.</li> <li>Future action: residents are encouraged to: call in at the time activity is happening (999) so that the police can attend and deal with appropriately, or come forward with any information they can provide to assist police in identifying activity or individuals (101).</li> <li>Should residents come across any drug related items such as sharps/needles please contact the council by calling 0344 980 3333. The removal of sharps will be arranged within hours of a report being received.</li> </ul>	



Summary of issues and actions raised		
Action		
Information: As residents will be aware Cavell Road is a home zone shared surface, 20mph street. It has been designed for vehicles and pedestrians to share the road space in a traffic calmed environment. Future action: There are two pairs of bus stops that are served by frequent bus services. The design logic of a home zone is that it is free of conventional road markings, however we appreciate that there may be issues where parking makes getting on and off buses problematic so we will investigate the possibility of installing bus stop clearways on the road. With regard to the request for parking permits we do not have plans at present to do this in the Cavell Road area, however we appreciate that commuters and football supporters do park in the area and the impact on local residents. We will keep this request on file when resources allow us to investigate this in more detail.

Issue or concern raised	Action	
<b>You were concerned for</b> the safety of children playing in the road	<ul> <li>Information: The police responded that there have been no incidents reported to police however, local children have been advised by officers on passing patrols regarding their safety while playing football within the road.</li> <li>There are facilities available locally where children can play such as Jubilee Park.</li> <li>Future action: Residents could consider organising "street play" sessions where the road is closed off to traffic. If you are interested in organising this contact the streetworks team on 01603 212203.</li> <li>Residents can apply to close a road for a local community 'street play' session, either on a one-off occasion or regularly each week or month. <b>You raised concerns about</b> sexual activity in the alley behind Cavell Road	<ul> <li>Information: No reports of this nature have been received. An offence of this type would be dealt by the police.</li> <li>Action: We encourage residents to call 999 when such activity is happening so police can attend and deal with appropriately at the time.</li> </ul>	



Summary of issues and actions raised		
Issue or concern raised	Action	
You told us you were concerned about dogs off leads and dangerous dogs on the loose from Springbank	<ul> <li>Information: The police responded to an incident August 2013 where a dog had been allowed to run loose from an address and been out of control in a public place. Their investigation is currently ongoing. There have been no other reported incidents.</li> <li>There have been no calls to police regarding dangerous dogs from the Springbank area.</li> <li>To report a concern regarding dangerous dogs please call the police.</li> <li>Action: Local SNT will incorporate into patrols and provide appropriate advice to dog owners to keep animals on a lead specifically around public highways.</li> </ul>
