NORWICH CITY COUNCIL (CATHEDRAL STREET, RECORDER ROAD, ST FAITHS LANE) (PROHIBITION OF DRIVING) (PART TIME) EXPERIMENTAL TRAFFIC REGULATION ORDER 2014...

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under sections 1, 2, 4 and 9 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. <u>Citation and Commencement</u>

This Order may be cited as the Norwich City Council (Cathedral Street, Recorder Road, St Faiths Lane) (Prohibition of Driving) (Part Time) Experimental Traffic Regulation Order 2014 come into effect for all purposes on the 12th day of September 2014 for a maximum period of 18 months.

2. (1) Definitions

In this Order -

"emergency vehicle" means a vehicle engaged on Fire Brigade, Police, Ambulance Service, Bomb Disposal Service or National Blood Service.

"Class 1, Class 2 and Class 3 vehicles" have the same meaning as in s3 of The Use of Invalid Carriages on Highways Regulations 1988;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS No. 4631: 1970), but coloured blue and capable of showing the quarter hours period during which a period of waiting begins; and

- (2) For the purpose of this Order a vehicle shall be regarded as displaying
 - (a) a disabled person's badge in the relevant position, when
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or

outwards and immediately behind the windscreen or side window nearest to the kerb.

3. Save as provided in Article 4, no person shall, except upon the direction of or with the permission of a police constable in uniform cause any vehicle to proceed into Cathedral Street, Recorder Road and St Faiths Lane at their junctions with Prince of Wales Road between the hours of:

Friday

11:00pm - midnight

Saturday

12:01am - 06:00am and 11:00pm - midnight

Sunday

12:01am - 06:00am

- 4. Nothing in Article 3 of this Order shall apply so as to prevent any person from causing a vehicle to proceed in the lengths of road specified in that Article if the vehicle is being used:
 - (a) emergency vehicle;
 - (b) Class 1, Class 2 and Class 3 vehicles;
 - (c) pedal cycle;
 - (d) motor vehicle with a valid residents or visitors parking permit and such use meets the terms and conditions of such a permit;
 - (e) motor vehicle for the access/egress of private parking spaces;
 - in the service of a local authority or water authority in pursuance of statutory powers or duties;
 - (g) in connection with the maintenance, improvement or reconstruction of that length of road or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer, water, gas, or electricity apparatus or of any telecommunications apparatus as defined in the Telecommunications Act 1984.

6. Modifications

The Head of City Development Services, in discussion with the Chair and Vice-Chair of Norwich Highways Agency Committee, may modify or suspend the operation of this Order or any provision of it in the circumstances specified under Section 10 (2) (a), (b) and (c) of the Road Traffic Regulation Act 1984.
