'De minimis' declaration

European Union law regulates state funded support to businesses and discretionary rate relief is classed as state aid. Under the "De Minimis" regulations, no one company/ organisation or sole trader may receive more than €200,000 of state aid in a three year period.

You can find out more about state aid on the government website https://www.gov.uk/state-aid

To apply for discretionary rate relief you should complete the enclosed application form. You must keep a copy of this letter for three years from the date you send in your application.

The award of discretionary rate relief must comply with state aid law and you must complete the declaration on the application form if you have received other state aid. You must confirm that the award of discretionary rate relief does not exceed the €200,000 allowed under the state aid regulations.

You must retain a copy of this letter and application/declaration for a minimum of three years and you must be able to present this to any other public authority or agency asking for information on "De Minimus" aid for the next three years.

You must continue to pay your business rates bill in accordance with the instalments shown on your latest bill whilst you wait for your application to be processed. Once your application has been processed any relief granted will be reflected in the remaining instalments.
